- will be scheduling a chaperone meeting the first week of August

Band Directors Report: Drew Balta and Dan Carlson via Zoom

- Mr Balta will be teaching Jazz 1 and Jazz 2 this coming school year
- Discussion of adding a couple of Jazz Festivals in Iowa that are known to be more competitive in nature than previously attended competitions
 - 1. Cedar Rapids, IA Festival at the end of February, 2023- would entail leaving SF after school Thursday, attending clinic and other educational opportunities on Friday, including a performance at the University of Iowa and joint concert with Des Moines High School, returning to SF late Friday evening to Saturday morning
 - 2. Morningside College, Sioux City, IA jazz festival
- Discussion: to address financial needs and concerns, idea of setting up a Jazz Band ISA account for involved students.
 - To create expense budget proposal for jazz festivals to set up an ISA and brainstorm fundraising ideas, by Drew Balta
- Discussion: will SFSD allow overnight stays for Jazz Festivals? How would transportation be set up? Would 2 vans instead of buses be possible? Dan Carlson will address with school administration
- Example: Winter guard set up their own Winder guard ISA and parents provided transportation for students
- Alternate Marching Band Competition proposal discussion
 - Instead of Brandon Competition, exploring idea of attending Pella Marching Band Competition on that same weekend, September 24, 2022.
 - Rationale: Pella is a significantly more competitive competition with the potential for more exposure, more productive and different judge feedback, attend by larger, more competitive schools. Also, not attending Northwestern Clinic anymore, which saves some money to offset additional expense of this competition.
 - Proposed weekend schedule: Leave 8am, travel to Des Moines, use Johnson HS facility with a partial unload of just instruments for a couple hour rehearsal, box lunches at rehearsal. Roadies continue on to Pella, IA. Band travels to Pella, IA, competition, then returns to SF around 3:00am
 - Pella has offered to waive registration fee this year to entice LHS to attend this competition
 - Concerns:
 - higher cost to attend Pella with fuel costs, not budgeted competition for 2022-23
 - roadies concern (additional travel time and fatigue, front ensemble equipment included in partial unload, expense to roadies for hotel that evening and availability of roadies to travel)
 - transportation availability in question
 - question of this would produce a relationship strain with the Brandon marching band program- Drew assured BPA it would be fully supported
 - question if this Fall is good timing to change competition venues with cost
 - issues, travel issues, planning for meals, transportation, but fully supported to attend Pella next season
 - Drew and Dan will further discuss

- Process for hiring outside staff, clinicians for this season's show needs to be defined- Dan
- Budget for outside staff, clinicians needs to be reviewed and updated.
 - currently comes from a small, \$6000 budget (funded from concert ticket revenue) for judges, jazz clinicians, equipment repairs, and the budgeted amount inadequate for projected need

 - Who is doing big group photo for breakfast with the band? Need to address date change with them?

 - Need to hire Chad Phillips Photography for photographing band
- New Member Day is July 27, 2022
 - Drew would like to have a grill out for section leaders and drum majors following new member day, do some grilling, watch a movie, etc in the LHS parking lot/Little Theater as a thank you for all of their hard work and dedication
 - Maria will send out request for a couple of grills to be brought to LHS as well as a request for drillmasters, then put out a sign up genius for food
